- 4. **Mike Kilo** (Bintulu Port Control Tower) has the right to stop this activity at any time without prior notice in order to protect the port's operations. Additionally, the following weather limitations will applicable to the stop work order:

4.1 Wind speed: 12 knots4.2 Swell height: 1.5 m

- 5. During this campaign, the <u>vessels involved</u> are reminded to activate her AIS system continuously and shall alert nearby vessels coming proximity.
- 6. The <u>vessels involved</u> shall report to **Mike Kilo** before any movement is made.
